**Emergency Overview:** Clear, colorless, odorless, thick liquid. Causes eye, skin, and digestive tract irritation. Spray mist causes irritation to respiratory tract. High pH is harmful to aquatic life. Noncombustible. Spills are slippery. Reacts with acids, ammonium salts, reactive metals and some organics.

**Chronic hazards:** No known chronic hazards. Not listed by NTP, IARC or OSHA as a carcinogen.

**Physical hazards:** Dries to form glass film which can easily cut skin. Spilled material is very slippery.  
Can etch glass if not promptly removed.

| <b>Acute Data:</b>           | When tested, sodium silicate 100% solids basis, its single dose acute oral LD50 in rats ranged from 3,200 mg/kg to 8,650 mg/kg.  |
| <b>Skin Irritation Data:</b> | The irritation response is inversely correlated with the molar ratio of the silicates; a lower molar ratio SiO <sub>2</sub> : Na <sub>2</sub> O leads to a higher irritation score and vice versa. This correlation is superimposed by the concentration effect: lower concentrations will exhibit lower irritancy as compared to higher concentrations of the same molar ratio. Whereas ratios of 2.0 and 2.4 exhibited irritating properties, ratios of 2.8 and 3.3 were not irritating. |
| <b>Eyes Irritation Data:</b> | Varying molar ratios exhibited effects in enucleated rabbit eyes ranging from corrosive (MR 1.0) to severely irritating (MR 2.0, 2.4 and 2.6) to slightly irritating (MR 2.8, 3.0 and 3.3).  |
| <b>Subchronic Data:</b>      | Sodium Silicate study shows that no changes to rats' organ when feed for six month NOAEL (180d) at 159 mg/kg bw/d  |

| <b>Ecotoxicity:</b>        | The following data is reported for chemically similar sodium silicates on a 100% solids basis: LC50 (96 hour) for fish (Danio rerio) of 1108 ppm at MR 3.46 ; EC50 (48 hour) for invertebrates (Daphnia magna) of 1700 mg/l at MR 3.20 ; ErC50 and EbC50 (72 hour) for algae (Scenedesmus subspicatus) is 345 mg/l and 207 mg/l at MR 3.0 ; EC0 (18 hour) for microorganisms (Pseudomonas putida) of 3480 mg/l at MR 3.46  |
| <b>Environmental Fate:</b> | This material is not persistent in aquatic systems, but its high pH when undiluted or unneutralized is acutely harmful to aquatic life. Diluted material rapidly depolymerizes to yield dissolved silica in a form that is indistinguishable from natural dissolved silica. It does not contribute to BOD. This material does not bioaccumulate except in species that use silica as a structural material such as diatoms and siliceous sponges. Where abnormally low natural silica concentrations exist (less than 0.1 ppm), dissolved silica may be a limiting nutrient for diatoms and a few other aquatic algal species. However, the addition of excess dissolved silica over the limiting concentration will not stimulate the growth of diatom populations; their growth rate is independent of silica concentration once the limiting concentration is exceeded. |
